> Income Tax for French tax payers resident in France

66%

of your donation is deductible from your wealth tax, subject to a maximum reduction of €50,000.

E.g. If you make a donation of €1,000 before 31 December 2009, the amount of income tax you pay will be reduced by €660.

> Wealth Tax for French tax payers

75%

of your donation is deductible from your wealth tax, subject to a maximum reduction of €50,000.

E.g. If you pay €1,000 in Wealth Tax, a donation of €1,333 before 15 June 2009 will enable you to reduce the amount of Wealth Tax you pay to €0.

DID YOU KNOW?

One year's studies on the Masters Degree course costs €12,000. **A donation of €1,000** finances one month's tuition for a student and costs you €340 after the income tax rebate or €250 after the wealth tax rebate.

The cost of an HEC MBA is €42,000. The average amount of a scholarship is €15,000. **A €5,000 donation** costs you €1,700 after the income tax rebate or €1,250 after the wealth tax rebate.

A €500 donation can contribute to financing the support of a research assistant to prepare a course. It costs you €170 after the income tax rebate or €125 after the wealth tax rebate.
